The Department of Dermatology at the University of California San Diego (<http://dermatology.ucsd.edu>) is seeking accomplished Scientists or Physician-Scientists at any rank to advance knowledge in Dermatology through basic research in Cutaneous Biology. The Department of Dermatology is committed to academic excellence and diversity within the faculty, staff, and student body.

The candidates will join a dynamic and productive group of independent investigators with research programs that include Immunology, Microbiology, Developmental Biology, or Cancer Biology in the skin.

The successful candidates will be expected to teach, perform research, participate in university service, and may choose to have clinical duties. Clinical duties may include the delivery of outpatient and inpatient dermatologic care with a subspecialty focus, which is possible based on the candidate's training and clinical experience. Once established, the scientists will be expected to compete for, and secure research funding at the regional and national levels.

The appropriate series and appointment at the Assistant, Associate, or Full Professor level will be based on the candidate's background and experience.
